GENERAL INFORMATION

Zinc 9-Plus is formulated for zinc delivery as a soil application for prevention or correction of zinc deficiencies. When applying in-furrow or on-seed fertilizer in dry soils, post planting irrigation is recommended within one day of application to avoid crop injury.

DIRECTIONS FOR USE

Soil Application:

Pop-up or In-furrow Application: Use 1-2 pints per acre with at least 3 to 5 gallons of fertilizer or water below, to the side, or in the seed furrow as established by local agricultural practices. Avoid on-seed applications in very dry or sandy soil conditions.

Starter Fertilizer, 2x2, Banded and Broadcast Applications:

Use 1-8 pints per acre with fertilizer or water.

Irrigation or Drip Application:

Use 1-8 pints per acre into drip, open, or pivot irrigation water. Repeat as required.

Compatibility:

Zinc 9-Plus is compatible with common fertilizers, including UAN, and liquid phosphate fertilizers. Do not mix with solutions that are sensitive to ammonia or contain potassium acetate. A jar test is recommended prior to preparing fertilizer blends of Zinc 9-Plus with other products.

Mixing and Handling Instructions:

Mix Zinc 9-Plus at a ratio of at least 20:1 in 80/20 orthophosphate or 1 quart of Zinc 9-Plus per 5 gallons of 80/20 orthophosphate fertilizer.

Start with the bulk carrier component (fertilizer or water), to a volume of about 2/3 the total finished blend. Under agitation, add any pesticides, adjuvants, or other nutrients and blend until mixed. Add Zinc 9-Plus, and fill tank with the remaining bulk carrier of water or fertilizer and agitate until mixed.

Application, storage, and handling equipment should consist of polypropylene, plastic, fiberglass, or stainless steel. Do not store undiluted Zinc 9-Plus in mild steel, aluminum, or copper vessels.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Store away from excessive heat and keep out of reach of children and pets. Always store Zinc 9-Plus above 32 °F and **Do Not Freeze**. Dispose of in accordance with federal, state, and local regulations.
