GENERAL INFORMATION

FOLIAR-COMPLETE 8-12-40 Water Soluble is an ideal High K, 1:2:5 ratio NPK + micros blend designed for Foliar application and/or Fertigation, and provides instant feeding through the roots and leaves. Foliar-Complete Water Soluble is fortified with Magnesium, Sulfur, and the essential micronutrients needed for color, vigor, and overall plant health.

DIRECTIONS FOR USE

GENERAL USE: Use this product as a foliar application to supplement the normal soil applied fertilizer program. Can be applied by aircraft at rates equivalent to 0.5 lbs to 2 gallons of water per acre. For back-pack sprayers use at a rate of 4 teaspoons per gallon. Broadcast rate 1-2 lbs per acre with ground rig. For transplanting dissolve 5 lbs per 100 gallons of water.

Balanced nutrition is essential to optimum plant growth and yield.

COMPATIBILITY: FOLIAR-COMPLETE 8-12-40 Water Soluble is compatible with most pesticides commonly used on row crops including Glyphosate applications. Do not use with highly alkaline spray materials. Add **FOLIAR-COMPLETE 8-12-40 Water Soluble** to the spray tank when it is at least half full. Agitation is suggested to increase the speed of solubility.
